### **DERBY FORMAT:**

This schooling derby will take place in the main Cross Country field at Hobby Horse Farm. Obstacles will be a mix of Cross Country and Show jumps. Certified Protective Headgear & Body Protector required. Equestrian Canada Eventing Rules for Dress & Saddlery are used as a guide.

#### Heights for this schooling show:

Pee-Wee - 18" (.45m) Pre-Entry - 2'3" (.70m) Entry - 2'9" (.85m) Pre-Training - 3'0" (.90m) Training - 3'3" (1m)

#### SCORING:

An optimum time is calculated for each level based on that level's xc speed. However, this time is not disclosed to competitors. Faults are assigned as follows:

<u>4 faults</u> for each rail at a stadium jumping obstacle <u>4 faults</u> for first disobedience at a sj obstacle <u>8 faults</u> for second refusal at a sj obstacle <u>20 faults</u> for first refusal at each xc jumping obstacle <u>40 faults</u> for second refusal at a xc jumping obstacle <u>0.4 penalties</u> for each second over or under optimum time <u>Elimination</u> occurs at 3rd refusal at same obstacle or 4th refusal overall (sj and xc)

**NOTE:** The Organizing Committee reserves the right to dismiss a rider from the course if considered unsafe or if the health and safety of the horse is compromised.



**ALSO**: for those not taking the clinic on June 1<sup>st</sup> who want to school cross country after the clinic is finished, there is a \$10 schooling fee to be included with payment, signed entry form & waiver.

I freely accept and fully assume all responsibility for the inherent 'RISKS' and the possibility of personal injury, death, property damage or loss resulting from my participation or my child's participation in Equine Activities.

In addition to consideration given for my participation or my child's participation in Equine Activity, I and my heirs, executors, administrators and assigns (collectively called my "Legal Representatives") agree:

- To waive all claims that I might have against the HOST (Hobby Horse Farm) and any volunteers.
