- Championship competition to be offered at Entry, Pre-Training and Training Levels
- Athletes to be members in good standing of their PHTA, PSO and Equestrian Canada at the sport license appropriate for their level of competition
- 2 scores from EC sanctioned eventing competitions must be submitted to their PHTA for consideration. These scores must be at the level they are applying to represent at Championships. At least one of these scores must be from a Horse Trial. At least one of these scores must be from the 2019 competition year. No scores received prior to 2018 will be considered.
- Only scores obtained from the athlete/horse in combination will be considered.

This is the MINIMUM Qualifying Criteria. Team selection from qualified athletes to be at the discretion of the PHTA. Contact your PHTA for further information and selection criteria.
