I Hereby certify that every horse, rider and or driver is eligible as entered and agree for myself and my representatives to be bound by the Constitution and Rules of Equine Canada at this competition. It is hereby recognized that all equestrian sports involve inherent risk and that no helmet, or protective equipment can protect against all foreseeable injury. I hereby accept this risk and hold harmless EC, the Competition, their officials, organizers, agents, employees and their representatives. The person responsible (PR) agrees to release any information on the entry form to EC (A802.4)

In the event that _____ participates in an Equine Canada sanctioned competition where protective headgear is required for juniors, he/she will wear properly fitted and fastened approved headgear at all times while riding or driving at the event location. It is understood that that juniors not meeting this requirement will not be allowed to compete at these competitions (A802.6)

The Person Responsible (PR) is responsible and accountable under the violation and penalty provisions of EC Rules for the care, training, custody and performance of the horse and must be present at the competition as well as sign and provide a license/member number on the competition entry form. The PR must sign the competition entry form at the EC sanctioned competitions. *The PR must be and EC Sport License Holder (which is inclusive of the Registered Participant/Non-Competitive License) in good standing and/or a provincial federation member in good standing. ***Please Note:** in the case of a junior/minor entries, a parent/guardian is entitled to sign as PR. Refer to Article 801.6. **Effective immediately, parents acting as the Person Responsible for their child's horse at EC competitions will no longer be required to purchase a Registered Participant License. EC is offering a full refund to any parents who purchased a 2018 EC Registered Participant License in order to comply with the former Person Responsible requirement.**
