**Team Selection Criteria:**

- 1) Member in Good Standing of NSEF and HTNS;
- 2) Top Score from 1 (one) sanctioned Horse Trials Competition that meets Eventing Canada's MER of:
  - Not more than \*45 penalty points (55%) in the Dressage Test
  - 0 jumping penalties at obstacles on the Cross Country Test
  - Not more than 75 seconds exceeding the optimum time or no more than 30 time penalty points in the Cross Country Test
  - Not more than 16 penalties at obstacles in the Jumping Test
- 3) Participation in a minimum of 2 (two) HTNS sanctioned Clinics between April 2018 and July 29, 2018;
- 4) Submission of declared horse fitness plan (This event requires long-distance travel, a vet check and jog prior to first day of competition. As such, it is imperative that your horse is physically fit);
- 5) Negative Coggins Test required within the last 12 months.

**Funding**

NSEF's Performance Pathway Program will cover the cost of entry and stabling fees up to a maximum of \$450.00 for each athlete. All other costs are the athlete's responsibility.
