



## Protect Your Horse from Getting Sick 5 Key Things You Need To Know

Infection control means doing what you can to prevent and control – it's all about lowering the odds of a sick horse

#### Disease costs you...

- Sick horses can't race, and can't bring in money – scratches affect your bottom line!
- Often, sick horses are contagious – they present a risk to themselves if raced, and to other horses at the farm, training centre, and track.
- Dealing with a sick horse can be stressful – missed racing days, vet bills and treatment costs, worrying about your horse's health, and whether the sickness





Your best approach is to be proactive and prevent a potential issue before it arises, and vaccines are your first line of defence:

They are very useful for preventing diseases caused by viruses (like flu and equine herpes virus) and bacteria (like Strangles).

They lower the odds of sickness, and limit how severe sickness will be – talk to your vetl



Antibiotics don't work for diseases caused by viruses, so prevention is the best option.

Remember, prevention is always cheaper in the long-run. So take action today!

#### Keep hands, clothes and boots clean!

- Wash your hands regularly with soap and water, and use a single-use towel to dry them.
- Use alcohol-based hand sanitizers regularly and make several available in the barn.



- Watch where you're touching your horse eyes, nose and mouth are where germs want to be don't give them a hand!
- **Designated boots** for the barn is best remember, they still need to be cleaned regularly.

#### Clean, Separate, Monitor

■ Cleaning surfaces, stalls, trailers, and tack and equipment, is another key to infection control

#### 3 steps to cleaning:

- Clean remove all visible manure, soil, and bedding
- 2. Wash with soap and water and let dry
- Disinfect apply disinfectant; ask your veterinarian
- Cleaning, Separating and Monitoring are the most important!

Give a sick horse its own stall as far away from other horses as possible.

Use separate tack and equipment – use a piece of red duct tape to label all equipment.

Place signs around so everyone knows

Work with sick animals last, and always wash up after handling them.

Talk to your vet once the horse has been separated.

Keys to monitoring your horse:

Think of **DEPPI** How are they: Drinking, Eating, Pooping, Peeing?

Do they have a snotty nose or a cough?

What is their temperature? Taking daily temperatures helps you spot issues before you see any signs.

#### Be selfish at the track!



- From your buckets, brooms and shovels, to your tack and equipment, "no sharing" should be your motto.
- Think of your time at the track like you're on a ride at the fair keep your hands, feet and equipment to yourself at all times it's about preventing the spread of germs!
- It's all about focusing on you and your horse, ask yourself:

How clean is your stall?

Are your hands and boots clean?

Is your tack and equipment separate from others and clean?

Can the crossties be shortened to prevent chewing? Are they clean?



Talk to your staff about what to do,

– And why it's important.

#### 2. Declaration of Quorum

#### 5. Business Arising/Action Items from the Minutes

- 1. Year Two Plan Update Presented as a separate agenda item
- 2. Helmet Rule Survey Results As a result of further consultation and member feedback, the NSEF Board of Directors has developed an amended Safety Initiative as it related to the use of approved helmets. NSEF thanked those members who participated in the Helmet Survey for Western Disciplines. Feedback and support of our safety initiatives was appreciated. We will continue to visit this survey as we move forward with helmet safety initiatives for our members.

The NSEF Helmet Use Policy is as follows:

All members participating in the NSEF Trail Ride/Drive and NSEF Clinics must wear an ASTM, SEI or BSI/BS EN approved safety helmet, with the safety harness correctly secured at all times while mounted or driving.

For NSEF Sanctioned competitions: All Competitors must wear ASTM/SEI, or BSI/BS EN, approved protective headgear, with the safety harness correctly secured at all times while mounted or driving at the competition or anywhere on the show grounds. If a senior competitor (19+ as of January 1st, 2015) participating in the Western Performance Division and Western Horsemanship Class without an approved safety helmet, the competitor must submit a signed Scotia Series Helmet Waiver to the competition organizer. There will be no exemptions for any other classes/divisions.

\*Individual Competitions can enforce stricter safety and helmet rules during their competitions which will take priority above the NSEF Helmet policy.

#### **NEXT STEPS**

NSEF will continue to promote and educate members on the

importance of wearing an approved helmet. We encourage members to wear helmets at all times while mounted or driving during any equestrian activity, whether recreational or competitive.

#### **EXECUTIVE DIRECTOR'S REPORT (SUBMITTED BY HEATHER MYRER)**

This past year has been a significant one for the NSEF in the areas of sport and equine related activities across the province. The collaborative efforts of volunteers, staff and members have allowed us to continue our progress in delivering the benefits of this sport to our members and to the horse community in general.

Through the generosity of Support4Sport and the Government of NS funding programs, we received new monies that provided us with the opportunity to hire a technical director. Gidget Oxner was hired as the first-ever NSEF TD in February. She is responsible for the delivery and success of our performance pathway initiatives - athlete and coach development, to be specific. NSEF acknowledges and appreciates the funding it has received from the Province of Nova Scotia via its Amateur Sport Fund and Support4Sport Funding. The success of our programs is certainly attributed to the funding we have received. We are excited about the upcoming athlete development training camps and several NCCP Coach Evaluations. We continue to work hard in facilitating the necessary courses and seminars that afford our members the opportunity to advance professionally within the sport of equestrian

We have embarked on creating a more modern "image" of the NSEF, starting with our new logo. By the time you have read this, our new website will be completed. We have also embarked on new social media endeavours – namely Facebook and Twitter.

We were thrilled to be able to provide six deserving young members a \$500 Educational Bursary this year. This program continues to be a popular one amongst members. We are equally thrilled to award four members with a Long-Term Equestrian Development Bursary of \$250 each.

Competitions continue to play an important role in our athlete development. We provide athletes with a provincial

based competition structure in Scotia Series and various competitions throughout the province are EC sanctioned – a positive step forward in providing a safe and friendly competitive environment for our many athletes. New to our athletes this year was the NSEF Skills Class in Jumping, Reining and Dressage. These classes were designed to assist us with tracking potential athletes for future high performance programs and national championships. Omega Alpha came on board as the Class Sponsor – adding a top prize for every class offered throughout the competition season!

Our 10<sup>th</sup> Annual NSEF Trail Ride/Drive was held last fall at the Porter's Lake Provincial Park. An exciting milestone for sure! It marked the final event for organizer, Suzanne Killen, who was instrumental in ensuring the success of this event year after year for the past ten years. It was decided that the next Trail Ride will be held in the spring of 2017 in conjunction with national Horse Day.

Our insurance partner, Intercity Insurance Services played an integral part in the development of our Optional Insurance Program for members. This new program has been well-received by members and will offer new additions for 2017. Members are encouraged to review these "optionals" at time of membership renewal. I would also like to acknowledge the support from Mike King and Intercity with his support of our Scotia Series in becoming the Title Sponsor and for all the educational and promotional expertise we have received since the development of this new partnership!

I would like to take this opportunity to thank our staff - Program Coordinator, Sheila Currie and Technical Director, Gidget Oxner - for their hard work and enthusiasm as we work diligently to provide you with quality programs and services. I would also like to thank the NSEF Board of Directors, especially President Adrienne Smith, for their direction and support throughout this past year.

#### DIRECTOR OF RECREATION REPORT (SUBMITTED BY KRIS FOLEY)

When people think about the equestrian sport they often visualize its competitive component, however a whopping 60% of all NSEF members are recreational riders! To help provide support for the recreational rider, the NSEF is pleased to continue to offer several Recreational programs to our members (Ride & Drive, Learn to Trail Ride, and the Learn to Ride Program) as well as access to Horse Welfare & Safety information and a listing of Equine Friendly Trails in NS.

The Ride & Drive Program offers members a way to track their riding/driving hours. Certificates and rewards are available as members reach specified hour levels. Currently the program has 331 members with a combined total of over 33,000 hours! To become a member or to learn more about the program, please visit the NSEF website (in the program section).

In partnership with Equestrian Canada, the NSEF is pleased to offer "A Guide to Basic Horsemanship and Trail Riding in Canada". This manual, available online on the NSEF website (Home page, Online Shopping) is based on current practices and tips gathered from members of the community, trail riding specialists, equine veterinarians, genetics specialists,

writers and knowledgeable horsemen and women. This guide will be used be used for a new Trail Riding and Tourism training program, in partnership with Equestrian Canada. More details about the launch of the program in Nova Scotia will be provided as they become available.

Due to scheduling conflicts, this year's Annual Trail Ride and Drive unfortunately was not held. However next year's event is shaping up to be a great one. The event will be held on the first weekend in June as part of activities planned to celebrate National Horse Day. While all details have not been firmed up yet, there will be apples and carrots for the horses and a BBQ (included with registration) will be held. Keep an eye out for more information on the NSEF website.

#### DIRECTOR OF EDUCATION REPORT (SUBMITTED BY MARY-CLARE MCLAREN)

Laducation and Coaching programs continued to grow and flourish this year, lots of happenings within the portfolio – accelerated with the addition of our Technical Director Gidget Oxner who we welcomed to our staff early in the spring. Our programs are well communicated on our website (soon to be relaunched), our Facebook and Twitter presence as well as through constant contact e-news. A quick review as follows.

The committee meets several times a year usually on a conference call to discuss items relevant to the committee. Additionally, we call upon other individuals from time to time. As an example, a working committee was called to develop the budget for Education for the coming fiscal year that included the Director of Competitions as some programs such as the Provincial Officials Program (POP) and development of the Skills classes within the Scotia Series are crossovers. This crossover has been most beneficial, as coaches, officials and competitions need to link together. This was also reflected at the EC Convention in the spring when the Stewards were presented with a review of LTED – a revelation for many! It is always good to know what the "other hand" is doing!

#### **NSEF Coach Symposium**

Another successful symposium was held in April. First Aid recertification was again offered to coaches with ten attending. We had a great opportunity to have two sessions with Jessica Dilliott, Head of Sport Science at Equestrian Canada. We were the first province Jessica visited in her new position. Jessica was inspiring with talks on topics including nutrition and cross training. She was able to take the yearly training plan and simplify an often overwhelming exercise, much appreciated by all in attendance! Forty-eight NCCP coaches and interested prospective or returning coaches attended the day sessions. Western Coaches (18) travelled to Creamery Brook for a technical updating as well.

#### **Theory Course**

A theory course was offered the last weekend in April with 15 registered.

#### **Equestrian Canada**

I was fortunate to again attend the Convention as Director of Education and although there were no formal coaching meetings as the committees are being restructured, there were some excellent working group discussions on the future of our sport. The interchange between disciplines was excellent. As you all now know, Equine Canada is rebranded – it may take you a while to get the new name but "EC" still works!

#### **NCCP Coach Transition**

Late in the spring, EC reconsidered the process of transitioning and with the approval of the Coaching Association of Canada transitioned all existing NCCP coaches into the new system. Some of us in the province had already gone through the transition steps previously in place and a number were able to do the transition update at the symposium presented by Jill Barker. The update was beneficial regardless. Any coaches unsure of how to activate and/or maintain their status are welcomed to contact Gidget for assistance.

LTED Bursary – Again a group of strong submissions for both categories were received. Congratulations to all the recipients of the bursaries.

**Education Clinic** –25 people attended our "Horse Show 101" Clinic presented in Sydney at Sport Fair this May.

#### **POP Officials Clinic June**

An evening session of classroom and practical – Module One – was held at Horses At Work and led by Sandra Conrad. This also acted as a very valuable resource evening in the development of the Skills Class – judge card design, values for scoring, and goals of the program. Feedback after the initial classes was invaluable, and as we moved through the season, the context of the class has taken shape in all disciplines.

#### Training Camp at Canada Games Center October 29th

Invitations are due to go out in early September to athletes identified through the NSEF Skills Classes which were held in the disciplines of jumper, dressage and reining. In addition, a number of athletes have been identified through the NSEF Talent Identification Program.

#### **Multi Discipline Coach Mentor Clinics**

A total of 15 participants (Instructor, Competition Coach and Competition Coach Specialists) took advantage of clinics offered at Horses At Work with Master Evaluator Jill Barker on July 5<sup>th</sup> and 13<sup>th</sup>.

#### **Multi Discipline Coach Preparation Session**

A total of eight participants from all three levels attended a session as Sport Nova Scotia.

#### NCCP English Coaching Evaluation

October 15<sup>th</sup> weekend will see a record number of candidates present themselves for evaluation and we wish them every success. This list at press time includes 4 English Instructors, 1 Western Instructor, 1 each English and Western Competition Coach and 1 each English and Western Reining Competition Coach Specialist.

#### **High School Credit Program**

Gracie Van Zutphen successfully obtained her NCCP Instructor Jump Certification this year and is our first member to come through the High School Credit Program. Congratulations!

#### Congratulations

Heidi MacInnes and Travis Smith both achieved their Competition Coach Specialist in English and Reining respectively this year as well.

**Learn To Ride Rider Levels** - The statistics as we go to press are very exciting as the numbers are growing. For me personally, it is exciting to see how the program in English has evolved since first launched as a ten level program in 2007. The English program has now been in existence long enough to see the progression from level to level and riders are now moving into the higher categories. At press time, 21 western rider levels and 172 english rider levels had successfully completed and many in the in-progress stage. We must continue to search for ways to reach out to all riders about the programs and promote the availability of coaches for pre-assessments, preparation training and evaluations. If a rider feels they are ready, they may contact the NSEF who can assist them in finding an evaluator. Western Coaches are in the final stages of having access to a Western Rider Level Progress Report. This will encourage riders to continue their preparation toward each level, a somewhat longer period than in the English system. P'tit trot is another entry-level program that further promotes and develops our five to nine-year-old rider!

I would like to thank the membership for the continued opportunity to volunteer on your behalf to the NSEF Board of Directors. As this report is written in early September to meet publishing deadlines, I look forward to providing you with further information at our AGM in November!

#### COMPETITIONS REPORT

NSEF was pleased to see growth in the Scotia Series in 2016 and the addition of several partners for the series. We anticipate that by the end of the season, 22 Scotia Series Competitions and 16 Equestrian Canada (EC) competitions (2 Bronze, 4 Silver/Bronze, 2 Gold-Bronze, and 8 Gold) will have taken place in our province.

In preparation for the 2016 season, NSEF held a successful Scotia Series Workshop in December of 2015. Following the workshop with assistance from several volunteers, the Scotia Series rule book was reviewed and updated.

We are grateful to Intercity Insurance for their partnership of the Scotia Series and Omega Alpha for their sponsorship

of the NSEF Skills Class Program. NSEF is also grateful for Support4Sport for its Athlete Assistance Program which NSEF used for the Skills Class.

NSEF developed the NSEF Skills Class for the disciplines of Dressage, Reining and Jumper as part of the Performance Pathway Initiative. Athletes' performance from these classes will be used to track the identification of athletes for our Provincial Team Program and will act as a stepping stone for future provincial team.

Although there was no national championship in 2016, we are anticipating that a new and improved CIEC will be announced for 2017. Watch for details in the near future!

#### VALLEY CLUB TAKES LEAD ROLE IN THERAPEUTIC RIDING PROGRAMS

Over the past several years, Alissa Cue has made a name for herself as a leader in the therapeutic and para equestrian field. As head coach and owner of at Rohan Wood Stables in Aylesford, Alissa has seen a tremendous increase in the need to provide programs for people with varying abilities. Born from that vision was the Free Spirit Therapeutic Riding



Association, a non-profit organization mandated to provide a safe environment for the enhancement of physical, emotional, educational and social development needs of clients through therapeutic riding and horsemanship.

Alissa Cue took a moment from her busy schedule to answer a few questions about this program.

**NSEF-** When did you start the Free Spirit Therapeutic Riding Association?

**AC**-FSTRA was started in the fall of 2012 as a pilot project with 12 riders. There was such a demand for the program that it has now grown to two 12-week sessions and a summer camp. We are able to provide service for over 100 clients a year.

**NSEF-** What motivated you to start FSTRA?

**AC-**I was approached by a group in the community about renting my facility and horses for a Therapeutic Riding Program. We were already adapting a lot of our programs so it seemed like a natural fit. It was such a great pilot that we decided to expand the program into what it is today.

**NSEF**- How many clients are participating in the program? **AC**- Over 100 clients currently participate in the program.

**NSEF-** What does a typical lesson entail?

**AC**-Within each lesson, riders complete various tasks. The first half of the lesson we refer to as their activity where the rider is learning a specific riding skill (stopping, walking,

steering, etc). The second half we refer to as the game portion of the lesson. It tends to be considered more fun, but still educational. We use a wide range of props and programming equipment in order to reach the goals as set out in each rider's individualized programming plan.

**NSEF**- Who can benefit from this type of program?

AC- Anyone can benefit from this program. Currently, we are working with clients who present with traumatic brain injury, PTSD, Autism Spectrum Disorder, cerebral palsy, depression, anxiety, eating disorders, Down syndrome, chronic illness, cognitive delays, spinal cord Injuries and mental health concerns.

**NSEF**- You recently received a grant from the Nova Scotia Department of Health and Wellness, how will this help FSTRA?

**AC**- This money will help us continue to expand our current programs allowing us to accommodate more clients. We are very grateful to the Department of Health and Wellness for their generous support of programs in rural Nova Scotia.

**NSEF-** FSTRA is accredited through Canadian Therapeutic Riding Association. Why is it important to be part of a larger national organization?

AC- It is very important to be a member of a national organization. Each accredited center goes through an exhaustive inspection process to ensure the safety of clients, volunteers and horses. CanTRA makes regular site inspections and guarantees that all of their coaches remain certified and current. Further to that, belonging to such an organization ensures a standard of programming for each client.
