






# 2021 Trail Ride/Drive Goes Virtual


# Interested in continuing your journey on the trails?

# Equestrian for Life

My Conversation with Mary Henry by Heather Myrer

recently had the wonderful opportunity to visit with the well-known and beloved Mrs. Mary Henry who was gracious enough to share with me so many of her memories and experiences as a life-long horse lover and teacher.

"My aunt came to King's-Edgehill during the war with her daughter as part of the evacuation and they rode there. When they returned to England, my cousin continued to ride. Naturally, I wanted to ride too. I was six, so that's when I began." Mrs. Henry continued to ride through boarding school, and at 18 years old, she travelled to Scotland and received her BHS certificate at the Edinburgh Barracks. "At 20, I came to Canada to work at King's-Edgehill. They knew I rode and that is when I began to teach. All the kids in town who wanted ponies were told that they could have their ponies at Edgehill barn if the Edgehill girls could use them. They paid \$3.50 a week to keep them there and Edgehill would use them. That's when bales of

hay were 25 cents each. And then we went from there."


In 1963, Mrs. Henry helped form the provisional pony club for Annapolis and Fundy region. The following year, the group became known as the Annapolis Pony Club. Thus began Mrs. Henry's influence on hundreds of students over three generations. Raising her family throughout the years was made somewhat easier as they were all involved in pony club right along with her.

Mrs. Henry worked with many instructors across the province and was always willing to share and learn information in equal parts. "I learned everything I had to do because I did it," recalled Mrs. Henry. "I came over from England and I could teach people how to walk trot and canter, jump over jumps, dressage, eventing and pony club." An accomplished rider in her own right, Mrs. Henry had great success with Sonny Boy. She trained him wherever and whenever she could and rode him to many ribbons, including a first-place finish at the Atlantic Winter Fair.

Mrs. Henry's influence is far and wide. She has passed a wealth of knowledge onto many Nova Scotia coaches over the years. But she is quick to add that she learned as much from people like Jane and Susan Fraser, Alex Beaton and Jen Hamilton over the years. "As much as I have taught over the years, I have learned a lot too," said Mrs. Henry. "I think that there are great people in our province who have a lot of knowledge. I have learned so much from people like Sue and Jane Fraser and Jenn Hamilton. If hadn't been for Jen (Hamilton), I wouldn't have done the pony hunter stuff that I do today. When she came, I was putting up two jumps for (her daughter) Sarah to practice and there was Jen shaking her head no. 'So I said, what should I do then?' " From that moment on, a lasting bond was forged between the two instructors. And also a respect for the depth of knowledgeable coaches in the province. "They are as good as anyone anywhere else. Learning from other instructors is important too," said Mrs. Henry. "When students are old enough to learn from another instructor it

Affectionally known as Mother Hen, Mrs. Henry has instilled in her students the importance of riding several times a week so that horses are fit, ready for the show ring and a lasting bond is developed. "The most important thing, I think, is to look after your horse. If it's looked after properly and ridden, it'll stay sound. If you do those things you're going to ride. She went on to add, "I keep saying that you DO have to ride. I often think to myself, I did more telling people we had to do two and three lessons a week. We went to camp and had two lessons a day. Ponies had to be fit. If you ride your horses, they won't go lame." Students also had to learn how to fall so they will get back on their pony she said. "That's the most important part, that they get back on next time"

Mrs. Henry said so many things have changed over the years, especially travelling to and from events. "I remember we would take all the kids to the first show in Lawrencetown. They rode in the top of the open truck with twelve horses in the back, head to tail. The

kids sat in the top part waving to folks as they went by. Would you see that happening today?" "When I taught, we did everything," she recalled. "All summer I had it set up that (the students) would have a lesson at their own place, then went to Hobby Horse, Truro for practices (on cross country), Hardy's and down to Sarsfields, all over. Then when we had the Rally, the kids could do it. I never had them practice show jumping because because they were always jumping, but needed to practice cross country and those distances. You've got to practise those distances!"

I asked Mrs. Henry what life lessons she thought were learned over her many years of instruction. Mother Hen said, "Well they did what they were told. They learned to listen which I think is very important. Even today with my leadline kids, they never let out a peep when I'm teaching. If they start to talk, 'I say I'm talking so you must listen.' And listen they do and it's great. They are safe and learning at the same time." Recognizing that things are different from the days when kids had no grooms and did everything from morning till night to look after their horse, Mrs. Henry offered, "All I say to people now is, 'that if you are going to do it (ride), do it for your own enjoyment and look after your horse properly."

Melissa Roy and Jennifer Lindsay, who hosted us on the terrace of scenic Albro Creek Farm in Falmouth, agreed that Mrs. Henry was and still is to them their Mother Hen. "Our mothers sent us to her to learn to ride and they also did as they were told. The way our barn ran was like an education for the parents as well. They learned about Pony Club through Mrs. Henry as much as her students did," said Jennifer.

Still dabbling in teaching, Mrs. Henry uses her life-long instincts to make up for some vision loss and continues to pass on the skills for the next generation of pony clubbers. Those lucky riders!

Not one to seek out attention, Mrs. Henry said, "OK, that's enough. Nobody wants to read more about me!" Maybe that's the case, Mrs. Henry but perhaps Melissa and Jennifer best summed up your legacy and the impact you have had on over three generations of riders when they both agreed that "We don't know where we'd be without Mrs. Henry!"

# Horses of Halifax Celebrating 85 Years



t's hard to miss the iconic stable and ring on Bell Road in Halifax. Most cities don't have a barn in the middle of their downtown core! This historical location is home to the Halifax Lancers (formerly known as the Halifax Junior Bengal Lancers), and they have a lot to celebrate this year—the non-profit equestrian school is celebrating its 85th anniversary! Throughout their history, the Lancers have provided lessons to both children and adults, and have run a therapeutic riding program for the community. Their famous Lancer Musical Ride (the only mounted youth performance of its kind in Canada) was established in 1936. Inspired by the RCMP Musical Ride,

it displays tradition, power, finesse and comradery. This tradition, carried on to this day, is a warm nod to their history and the performance is an exciting way to engage with both the equestrian community and the community at large.



# 50 Years of Windsor Spring Horse Shows

# Celebrating a Remarkable Milestone

This year marks an important milestone for Windsor Spring Horse Show, celebrating 50 years of equine excellence in competition. Originally founded by Harry and Ann Ainsworth in support of the Lion's Club, the show was donated shortly thereafter to the Avon Pony Club in 1972, the year of the club's inception. Prior to the Avon Pony Club's involvement, the Windsor Spring Horse Show was a different show than what it has developed into over the last 50 years. In the early years of competition both English and Western disciplines were represented.



In 1972, the Avon Pony Club formed when the Annapolis Pony Club split into three separate clubs: Annapolis Pony Club, Fundy Pony Club, and Avon Pony Club. Historically, Windsor Spring Horse Show signaled the opening of the competition season in the Maritimes. To this day, many of the names that graced the entries/Prize List in days past are still a part of the Windsor Spring Horse Show and the current Maritime equine culture: Willowbank Farms, Mary Henry, Jill Barker, Kevin Crosby, Sandra West Conrad, Judy Covert and many more who have helped shape and sustain the equine industry in Nova Scotia as we know it today. Over the years, Windsor Spring has always tried to maintain the traditions set in the early years (like the Maritime Bred class) while also managing to adapt to current standards of the industry all while keeping the spirit and values of Avon Pony Club: Loyalty, Sportsmanship, and Character alive.

Due to the unprecedented times over the past two years, Avon Pony Club made the decision to reschedule the show from its usual date of the May long weekend, to October 14-17, 2021 in an effort to comply with public health directives and provide a safe competition for all to enjoy. Plans are well underway, and thanks to our generous sponsors and supporters, we are excited to welcome all competitors back to Windsor Spring in the Fall. We hope to see you all there!

Membership rebounded after the 2020 shutdown and the 2021 spring and summer calendar was populated with many events/clinics/competitions all over the province once again! So great to see! Many, many updates and revisions were made to our return to plans; lots of emails to members and zoom sessions galore were the new norm.

The Board of Directors and staff continue to work from our Five-Year Strategic Vision and targeted Year-Two priorities. The collaborative efforts of volunteers, staff and members have allowed us to continue progress in delivering many of some of our initiatives and a few news ones, in spite of Covid-19. Others have been postponed with the anticipation that they will resume in 2022.

We continue to benefit from financial support from the Support4Sport Program and the Government of NS. We received funding that assisted us with athlete development, technical support, coach symposium, clinics and educational seminars. NSEF acknowledges and appreciates the funding it has received from the Province of Nova Scotia via its Amateur Sport Fund and Support4Sport Funding. We are always excited when we are able to offer new programs and services to you, our member. We also work hard in facilitating the necessary courses and seminars that afford our members the opportunity to advance professionally within the sport of equestrian. Further to direct funding to the NSEF, many of our members have successfully applied for athlete, coach, official and club development funding. To date we have had a 90% funding approval rate and have seen many members take advantage of this funding. You are encouraged to utilize this opportunity by contacting a staff member as there are timesensitive deadlines that may affect the programs for you which you may be eligible. We were thrilled to be able to provide six deserving young members a \$500 bursary this year. This program continues to be a popular one amongst members. We are equally thrilled to award four members with a Long-Term Equestrian Development Bursary of \$250 each. Our plan is to offer several new bursary-type initiatives in 2022 that will impact equine health and welfare and inclusion.

Competitions continue to play an important role in our athlete development, as does our relatively new athlete performance program. We developed a new online competition management system that will provide organisers a platform to manage everything from date notification approval to entries and scheduling. We introduced this on a small scale this year to work out the challenges. This system will play a significant role in safe sport standards and compliance for coaches and officials as well.

We were very pleased with the virtual member engagement and educational opportunities that became the "silver-lining" this past year. We had the most successful in numbers hybrid Coach Symposium this past spring and have further developed our provincial officials' program. We have been so fortunate to partner with some of our clubs to further enhance our programs as well. Our partnership with Equine Guelph to offer The Horse Portal is seeing a lot of growth. The online Large Animal Rescue Course was such a huge success that it was offered twice. The educational and professional opportunities offered on The Portal is second to none! ver the past year, we continue to make great strides in connecting industry partners with NSEF. We continue our discussions with the Nova Scotia Department of Agriculture and continue to promote the Premise ID program, endorsed by Equestrian Canada (EC), is available on our website. This is a free program and in the event of a natural disaster or emergency could help save your animals. Further, NSEF has developed a partnership with Horse Welfare Alliance of Canada (HWAC) and though this partnership also has a connection with the Canadian Animal Health Surveillance System (CAHSS). The Canadian Animal Health Surveillance System (CAHSS) is comprised of several caring professionals from Canada and elsewhere with a mission dedicated to informing Canadian livestock industry participants, including equine, respecting issues, updates and information directed to animal health and welfare. These are important steps as we focus on the health and welfare of horses within NS and the horse industry overall both within and outside our province.

Our relationship with Equine Guelph and The Horse Portal is as strong as ever! If you haven't taken a course, please don't hesitate this fall.

In keeping with the theme of partnerships and communication, NSEF, through EC, maintains a close relationship with the Canadian Food Inspection Agency (CFIA). When notices are received from the CFIA regarding national and infectious diseases affecting horses, EC notifies the equestrian community and the media. I attend the monthly National Equine Disease & Welfare Surveillance meetings that are meant to facilitate timely updates and collaborative communication across Canada regarding equine disease and welfare, links to these can be found on our website. As well, we have links to free webinars from HWAC and links to the Equine Code of Practice along with a host of other resources which focus specifically on industry.

We are committed to the social contracts we have with our horses, to take care of them both physically, mentally, socially, etc. We will offer educational seminars that cover subjects that are requested by our membership that connect to industry both specifically and broadly so that the health and welfare of our horses remains at the core of who we are as equestrians. # NSEF BOARD OF DIRECTORS' NOMINATIONS PROCESS



The Nova Scotia Equestrian Federation (NSEF) is recruiting new volunteer Board members with varying professional backgrounds and skill sets.

Our organization and its Board are committed to a culture of inclusion. We would like to welcome Board members with skills, competencies, talents, identities, backgrounds, and perspectives across a broad and diverse range of leaders to enable us to achieve our goals and broaden our impact.

One of the goals of the NSEF's Strategic Priorities - ORGANIZATIONAL EXCELLENCE AND SUSTAINABILITY is to have a strong and effective Board with a defined governance structure and succession plan. One of the ways we support this priority is to recruit members to serve in the various Board of Director (BOD) positions. Developed by the BOD, a robust application process is led by the NSEF Nominations Committee ("the Committee"). The NSEF Boardapproved process allows for the Committee to seek out members with a specific skill-set and interest in serving on our BOD. Once the Committee completes its role, a slate of successful candidates is presented for vote at the Annual General Meeting (AGM). This process is considered critical for organizations to fulfill their moral, legal, and ethical responsibilities to all those they reach, including members, employees, and volunteers. The benefits of a predetermined slate of nominees include:

- Ensuring that the candidate skills and experience are aligned with the needs of the organization and BOD;
- Ensuring that conflicts of interest do not affect the quality and safety of programs and services offered by the NSEF;
- Reducing the risks and liability for members, employees and volunteers.

As a result of this nomination process, the Committee is able to ensure that all candidates presented to the membership are qualified and evaluated using a consistent criteria and process as outlined in the Candidate Application Package.

#### **Term Limits: Per Bylaw Article 33**

The BOD shall be comprised of Adult Individual Members of the NSEF, elected by the membership as follows:

To preside for a two-year staggered term, not exceeding two consecutive terms, a) Director of Competitions; b) Director of Education; c) Director of Recreation; d) Director of Equine Industry.

To preside for a three-year term, six (6) Directors at Large – whereby, at each AGM, two (2) Directors- at Large are elected.

At a club meeting prior to the Annual General Meeting (either in person or via conference call) a director representing Member Clubs will be nominated to serve on the NSEF Board of Directors. The Nominee must first be endorsed by his/her representative club. The newly nominated Director will be on the slate of Nominees for Election by the members at the AGM and will preside in this position for a one-year term.

#### **Competency of Nominees**

All nominations shall be reviewed by the Committee. The Committee shall provide the Members with a list of candidate Directors, taking into consideration the required skills and diverse needs of NSEF and the community it serves and a balance of new and experienced directors. If possible, the list of candidate directors shall exceed the number of vacant positions by at least one and at most double the number of vacant positions. No candidate may be eligible for election as a director unless such candidate has been reviewed by the Committee.

#### Eligibility: Per Bylaw Article 34

Any Voting Adult Member in Good Standing of the Federation shall be eligible to be elected a Director of the Federation.

#### **Nominations**

Nomination of an individual for election as a Director shall be submitted to the Committee by a current NSEF member in good-standing, in accordance with NSEF's Nomination policy, procedures and timelines. The Nomination shall include a written confirmation by the candidate expressing a willingness to stand for office, including a detailed profile of the candidate. Please note that portions of each successful candidate application may be used by the BOD to promote an applicant to the general membership. All applications will be destroyed following the presentation of the slate of candidates to the membership.

#### **AUTOMATIC INSURANCE PRODUCT DESCRIPTIONS**

#### \$5,000,000 Personal Liability Insurance (\$1000 Property Damage Deductible)

Protects you, the member, if you are sued by a third party because a horse that you own or lease, ride or handle non-commercially, causes property damage or bodily injury to a third party. \*\*Liability coverage is for non-commercial equine related activities. Some limitations and exclusions apply. Coverage is in force 24 hours a day, seven days a week, and covers the member (Canadian resident) anywhere in the world. (Exclusions apply for members who are non-Canadian residents).

#### \$30,000 Accidental Death & Dismemberment Coverage

Covering you, the member, should you suffer a catastrophic injury, dismemberment or death arising from equine related activities. (Under the age of 90 and only available to Canadian Residents)

#### **OPTIONAL INSURANCE PRODUCT DESCRIPTIONS (2022 ONLY)**

# NSEF Optional Accidental Death & Dismemberment INCLUDES Fracture and Dental Benefits (ADD)

\$50,000 - Enhanced Accident, Death and Dismemberment for injuries sustained by you, the member related to horses, including coverage when you are en route to and from an equine activity in a vehicle. This policy will pay regardless of any other insurance that may be in force at the time of the incident. \*Enhanced AD&D is restricted to members who have not reached the age of 75 years

#### **NSEF Members Named Perils**

\$10,000 – Horse Mortality (Named Perils). Horse(s) you own are covered for death arising from Fire, lightning, transportation, earthquake or flood, attack by dogs or wild animals. Limit of \$10,000 any one loss and any one term. Includes compensation for government ordered destruction of horse. This policy must be purchased by the owner of the horse(s).

#### NSEF Emergency Life Saving Surgery (Must be purchased with Members Named Perils)

\$2,500 Emergency Life Saving Surgery – This policy covers Emergency Life Saving Surgery necessitated by accident or sickness, including colic surgery and fracture surgery, to a maximum limit of \$2,500.00 for expenses incurred (\$250 deductible). PLEASE NOTE: This is NOT a life insurance policy; NO DEATH BENEFIT is payable under this policy. This policy is restricted to one claim per year and must be purchased by the member who is the owner of horse(s). Members Named Perils 2022 must be purchased in order to purchase this product.

#### **NSEF Members Tack**

\$10,000 – Tack and Equipment - Insurers tack and equipment from loss or damage anywhere in Continental US/Canada. Tack and horse equipment you own, excluding rider clothing and protective equipment is insured against loss or damage from "all risks". Limit of coverage is \$10,000 for any one loss, total limit per term. Losses subject to deductible of \$500,00

#### Travel (out of Province/Country) Coverage - Member Only

Covid-19 restrictions have impacted coverages available to you, our member. As a result, out of province/country travel insurance coverage at an NSEF member rate may be obtained by contacting our provider directly. Please call our partners, CapriCMW, at 1-888-394-3330 to discuss options available to you.

#### Weekly Accident Indemnity (WAI) (Please contact the NSEF office for additional paperwork before purchasing this coverage)

Provides <u>income replacement</u> in the event you are unable to work due to an accident. Coverage is in force 24 hours a day/ 7 days a week and includes (but is not limited to), injuries arising from an equine related incident. There is a 7 day waiting period. The policy will provide *up to* \$500.00/week in income replacement for *up to* 26 weeks (some restrictions apply). The combined benefit from this policy and all other benefits available to you (WCB/WSIB/CPP/ Employer Group Programs, etc.) cannot exceed 75% of reported gross income to Canadian Revenue Agency in the most recent taxation year. To qualify for this special program and be eligible for benefits, you must meet the following minimum requirements:

- 1) Be a resident of Canada.
- 2) Be a member in good standing of your provincial equine association;
- 3) Be employed full time (minimum of 25 hours a week with a single employer);
- 4) Be under the age of 70 years old; and
- 5) Filed an income tax return to Canada Revenue Agency in the most recent year.
